The Structured Decision Making[®] (SDM) system is a suite of research and evidence-based assessment tools used by social workers to help guide decision making at key points in the child welfare system. Implementing these tools effectively requires bringing diverse voices to the table to ensure that accurate, consistent, and equitable decisions are being made for all families in California.
